



Transferable Limited Lifetime Warranty Aluminum Fence and Rail

What is covered: Barrette Outdoor Living warrants its aluminum fence and aluminum railing against defective materials or workmanship for as long as the original homeowner/consumer owns his or her home. If original purchaser is a corporation, partnership, government, or public entity (including a church or school), or other commercial user, the Warranty period shall be twenty (20) years from date of original purchase. Barrette Outdoor Living warrants these products will not flake, rot, blister, corrode, or suffer abnormal discoloration under normal use, service, or care. This warranty extends to the original purchaser or transferee as specified herein.

What this warranty does not cover: This limited warranty does not cover damage resulting from accident, misuse, unreasonable use, neglect, alteration, improper service, improper installation, impact of foreign objects or acts of God. This warranty does not cover products exposed to environmental conditions such as air pollution or foreign substances such as dirt, grease, oil, solvents, glues, paints, chemicals (including lawn fertilizer and lawn care chemicals), or foreign substances (including but not limited to tree sap, leaves, bug sprays, pine needles, fertilizers, etc or any other causes not arising out of defects in materials or workmanship. This warranty also does not cover variations or changes in color due to exposure to sunlight, weather and atmosphere. Additionally, this warranty does not cover costs of installation, removal and reinstallation or surface mold and mildew created by excessive environmental conditions.

Any service or repair provided outside the scope of this limited warranty shall be at Barrette Outdoor Living's rate and terms then in effect. *Barrette* reserves the right to discontinue or modify any of its products, including the color of its products, without notice to the homeowner/consumer, and *Barrette* does not warrant that any replacement material will match or be identical to the original product as replacement products may vary in color or gloss in comparison to the original product as a result of normal weathering. If *Barrette* replaces any material under this Warranty, it may substitute products designated by *Barrette* to be of comparable quality or price range in the event the product initially installed has been discontinued or modified.

What do we do to correct the problems: Should your Barrette Outdoor Living product prove defective under warranty, the purchaser should notify Barrette in writing at the following address:

Transferee Coverage: Warranty coverage will be extended to transferees on the above listed products with the following limitations. Transferee must obtain an original or copy of the initial sales receipt (with proof of date) from the previous owner(s). Additionally, if aluminum fence or rail is purchased from a builder or installer, documentation must be supplied that names the product installed on property and date of transfer.
